The bill is currently in the **Joint Committee on the Judiciary**. Members of the Judiciary Committee, including both Vice Chairs, already co-sponsor this measure. The bill has been endorsed by 50+ community organizations, including the Massachusetts Bar Association, Greater Boston Legal Services, and the Public Health Institute of Western Massachusetts.
